Where is OMV Petrom located?

On December 2, 2010, OMV Petrom inaugurated Petrom City, the headquarters that hosts the company's central operations. Situated in the northern part of Bucharest, it will be used by around 2,500 employees from 7 headquarters of the company in Bucharest and Ploiesti.

How much energy will OMV Petrom produce a year?

The estimated annual production will be about 130 GWh. The next step in this project is the start of construction, with completion and commissioning expected to occur in the first half of 2026. This project supports OMV Petrom's goal to have a portfolio of 2.5 GW of renewable energy projects, together with partners.

What does OMV Petrom do?

OMV Petrom is active along the entire energy value chain: from exploration and production of oil and gas, to refining and fuels distribution and further on to power generation and marketing of gas and power.
