

Wie registriere ich eine Photovoltaikanlage?

Die Registrierung einer Photovoltaikanlage bei der Bundesnetzagentur erfolgt online über das Marktstammdatenregister (MaStR). Dabei müssen Sie einige grundlegende Daten angeben - beispielsweise die Art der PV-Anlage, ihre Leistung sowie den Standort. Ein digitaler Registrierungsassistent unterstützt Anlagenbetreiberinnen bei der Registrierung.

Was passiert wenn ich meine Solaranlage nicht registriert?

Wenn Sie Ihre Anlage nicht registrieren, drohen ein Bußgeld und der Verlust Ihrer EEG-Vergütung. Die Eintragung kann nur online erfolgen - es gibt keine Papier-Formulare dafür. Besonders praktisch: In vielen Städten und Gemeinden lässt sich ein Gewerbe für die Photovoltaikanlage online anmelden. Dabei kommt ein spezielles Formular zum Einsatz. In der Regel erhalten Sie kurz im Anschluss eine Bestätigungsanmeldung vom Finanzamt, das die Informationen weiterverarbeitet. Was kostet die Anmeldung einer Solaranlage?

Doch vor der Inbetriebnahme einer neuen Solaranlage gibt es manche bürokratische Hindernisse. Bevor die Sonnenenergie fließen kann, müssen private Betreiberinnen und Betreiber sie sowohl im Marktstammdatenregister als auch beim Netzbetreiber registrieren. Die Anmeldung einer ortsfesten PV-Anlage ist in Deutschland gesetzlich vorgeschrieben.

Ist eine Solaranlage gewerblich?

Angaben zum Netzanschluss Grundsätzlich gilt: Wer eine Solaranlage betreibt und Strom ins öffentliche Netz einspeist, ist gewerblich tätig. Betreiber von PV-Anlagen mit einer Leistung unter 30 kWp sind allerdings seit 2023 von der Gewerbesteuer befreit - bis dahin galt die Höchstgrenze von 10 kWp.

Ist eine Solaranlage meldepflichtig?

Laut Bundesnetzagentur gilt die Meldepflicht für Solaranlagen für alle ortsfesten Stromerzeugungsanlagen und mit dem öffentlichen Versorgungsnetz verbundenen Anlagen - unabhängig von ihrer Größe, dem Zeitpunkt der Inbetriebnahme und der Inanspruchnahme von Förderungen nach dem EEG.
