Will Uzbekistan fund a 250-megawatt solar photovoltaic plant?

TASHKENT, May 21, 2024 -- The World Bank Group, Abu Dhabi Future Energy Company PJSC (Masdar), and the Government of Uzbekistan have signed a financial package to fund a 250-megawatt (MW) solar photovoltaic plant with a 63-MW battery energy storage system (BESS).

Who owns the energy sector in Uzbekistan?

The government owns and manages the energy sector in Uzbekistan. The Joint Stock Company-Uzbekenergo, a vertically integrated and publicly owned monopoly (in charge of electricity generation, transmission, and distribution), operates under the supervision and regulation of the Cabinet of Ministers.

How can Uzbekistan meet its energy needs?

Uzbekistan is capable of meeting its energy needs from its own energy resources. Uzbekistan owns a significant part of the installed capacity of the united power system of Central Asia.

What is a joint development agreement between Masdar & Uzbekistan?

A joint development agreement (JDA) was signed between the pair in May 2023 for 2GW of wind energy and 500MWh of battery storage, as reported by Energy-Storage.news at the time. UAE-based renewable energy company Masdar has expanded agreement with Uzbekistan to develop battery energy storage systems (BESS).

Masdar has recently signed a joint development agreement with Uzbekistan's Ministry of Energy (MoE) and the Ministry of Investments, Industry and Trade (MIIT) to develop over 2 GW of solar and wind projects and 500 MWh of battery energy storage at multiple sites across the Central Asian country.

The ADB is proposing a large scale, solar-plus-battery system in Uzbekistan.
